Guidelines for Authors

1. Introduction

The Journal of Humanities and Social Sciences (JHS) publishes previously unpublished high-quality research in the humanities, the social sciences and allied fields. While its primary objective is to serve as the publication platform for research work of the Postgraduate Institute of Humanities and Social Sciences, it also encourages researchers attached to universities and research institutes in Sri Lanka and abroad to use the JHS as an outlet for their research work. The Editorial Board of the JHS takes into account the theoretical contribution and, where relevant, applicability of the findings when considering articles for publication.

2. Publication Ethics

Articles submitted to the journal should not have been published before in their current or substantially similar form, or be under consideration for publication in a journal/book or any other form. Authors of papers should properly acknowledge the original source information.

3. Copyright

The copyrights of articles and papers published in the journal are reserved by the JHS. Authors should obtain permission, in advance, from the Editor of the Journal to reprint/reproduce a whole or a part of a paper published in the journal. Publication of the main chapters of an MPhil or a PhD thesis/dissertation in internationally accepted journals/ edited volumes must be done as a joint publication. In the event the supervisor's name is not included in the article written concurrence must be provided by the primary author.

4. Review Process

Each paper is evaluated initially by the Editorial Board for suitability for publication in the Journal. If judged suitable for publication, the paper will be sent to two

reviewers for double double-blind peer review. On the recommendations of the reviewers, the Editorial Board of the journal decides whether the paper be accepted as it is, revised, or rejected. The Editorial Board of the Journal reserves the right to copy editing papers accepted for publication. When there is a significant discrepancy in the recommendations of the two reviewers, the article shall be sent to a third reviewer. In such a case, the decision shall be made based on the two closest review reports.

5. Structure of Papers

Research Articles may include the following sections:

Introduction, Literature Review, Methodology, Analysis / Discussion, Conclusions and References.

Review Articles may include the following sections:

Introduction and Background, the Body of the Paper, Conclusions and Future Direction and Literature references.

OR. IF THE AUTHOR IS UNKNOWN

Department of Lifelong Learning (2001), CAE0001LWR Unit 5: Note taking skills from lectures and readings, Exeter: Author.

(NB – 'Author' at the end means that the publisher is the same as the author)

7. First Submission

- A softcopy of the paper (MS Word) should be sent to the JHS by email at jhs@pgihs.ac.lk
- Authors should provide the following information in a separate sheet:

 Title a brief biographical note of each author including full name affiliations address for all correspondence, telephone and e-mail addresses and Acknowledgement (if any). In the case of multiple authors, one author should be identified as the corresponding author.
- The article/paper, which will be sent to reviewers, should include the following: <u>Title Abstract Keywords</u>, <u>Text</u> and a complete list of <u>References</u>. The author(s) should not be identified anywhere in the text.

8. Final Submission

Once accepted for publication, the authors are required to send the final version of articles/papers in both MS Word. The manuscript submitted shall be the definitive version of the article. The author/s must ensure that it is complete, grammatically correct and free from spelling or typographical errors. Authors are also responsible for responding to subsequent editorial comments in a timely manner.
